CAPP is seeking a highly motivated and detail-oriented Tolls and Tariffs Summer Student to join our team. In this role, you will be responsible for assembling a comprehensive resource manual and providing overall support to the Tolls and Tariffs team.

- Identify and compile information on primary North American oil and gas pipelines utilized by CAPP members for product shipment to the market.
- Gather key pipeline statistics and descriptions, including operational details and infrastructure specifications.
- Establish a list of contacts associated with each pipeline, ensuring accurate and up-to-date information.
- Provide data on Canadian volumes flowing through each pipeline, along with corresponding shipper names.
- Summarize historical toll proceedings in which CAPP participated, whether litigated or settled, and identify key issues and regulatory principle. Develop a resource manual outlining key regulatory principles related to pipeline hearings.
- Identify and document key legal cases relevant to regulatory matters.
- Compile information on additional CAPP regulatory principles, emphasizing cases that can be relied upon for consistency and future guidance.
- Day to day support for the Tolls and Tariffs department, as well as other departments as needed.

- A self-starter who takes initiative and has excellent interpersonal and collaboration skills
