Aviation safety alerts and awareness

- CHI Customer Flight Notifications
 - o 10 since Feb-3rd meeting
 - o 8 of them would not be issued if the flight notification clarification protocol were in effect. They would not meet the criteria or threshold.
- CHI-ASAW-2021-01 Temporary Ban Lithium Batteries in Cargo
 All Lithium Batteries are considered Dangerous Goods (DG) and can only be shipped in accordance with the appropriate Packing Instructions. In light of a recent event, Cougar Helicopters will be temporarily banning the carriage of Lithium Batteries as cargo.
- Must Read Biohazard Waste Containers. CHI-SAL-2021-05
 Cougar Helicopters Inc.(CHI) has recently added two safety biohazard containers to their facilities.
 These containers provide an additional barrier for potentially infectious substances that are identified within their operations, ensuring a mechanism for immediate containment and subsequent offsite disposal by a professional third-party agency.
 Operators advised that they have similar containers in use offshore.
- Must Read COVID-19 Transport Protocol and Must Read Wearing Face Masks On Board Offshore Flights, Rev 5
 CHI are continuously updating protocols as required and are communicating these to their personnel via a structured system which included must reads.
- 09.04.2021 Safety moment helicopter Mariner A
 - o 30th March 2021, Helicopter had to be moved to permit a second helicopter to land with engineers onboard to address a maintenance issue with the first.
 - Aircraft was manually pushed off the main helideck over a grated area. The starboard rear wheel penetrated the deck grating.
 - No injuries.
