CNLOPB Safety Forum Nov 7-8

- Extended Flight Day options for single operator-See response under extended flight day
- Use of Armbands for XL- Previously reviewed and HOSC members decided not to pursue.
- Distance between helicopter seats-Was addressed previously at HOSC, since same S92 and same HUET with same seats and windows, review not required
- Headset for passenger use in Cabin for communication with the flight crew-All operators have approved its use, operator roll out 3 weeks out possibly

Items communicated by JOSH

- Husky SeaRose- question regarding additional 1200lb payload increase with S-92. Mike will send history/summary to HOSC for review

Future Agenda items/ New Business

AFFF Minimums

- Incident on a facility resulted in a 60% minimum requirement to now be 90%. Periodic testing brings down the levels and with the incident brought the levels down under min requirements to have onboard. Minimum levels at that facility now 90% vs previously 60%

HOSC Charter Review

- Review complete, each operator representative to provide details for management signoff
- Distribution list updated
- Continues to permit CNSOPB participation

OHSI Recommendation #7 Review

- Reviewed proposed changes
- Recommending clarification of Customer Flight Notification requirements
 - Non safety items, non-events, are preventing focus on those that should receive attention
 - Define terms, including the criteria that constitutes a briefing
 - A cabin announcement does not constitute a briefing
- All participants support these changes, working group formed to work on proposal to submit for approval

SAR Aircraft AIS

The PLB's attached to the SURVITEC helicopter transportation suit have AIS capability
AIS receiving and software visualization equipment will be in place on the Operators SAR providers
aircraft prior to the end of Q1 2019

- Two portable units to enhance SAR capability and PLB detection/passenger location
- Portable units provide quick equipping of SAR and non SAR aircraft to assist in activity if required
- Successfully trialed in the S92 SAR aircraft
- Includes integration into the existing cockpit iPads
- CHI SAR team see it as very important tool that that will be integrated into the SAR program.
