Membership dues are based on the calendar year, and can be pro-rated for the number of months left in the year. However, companies joining on or after October 1st of a given year are required to pay the dues for the balance of that year plus the following year's annual dues.

¹ **Liquids:** Conventional-light medium and heavy, pentanes plus and condensates, propane, butane and ethane.
² **Oil Sands:** Includes mining (except Syncrude Canada, which will include all joint venture production in its own calculation) and in-situ (includes primary production within defined oil sands areas).
³ **Natural Gas:** Natural gas sales.
⁴ **2018 Total Canadian Production estimate:** Calculated using 12 month average daily production ended September 30, 2017 (**net before royalties**) plus the average daily production from any acquisition and/or joint venture that will be producing in 2018 using the same 12 month daily average calculation.
⁵ **Minimum dues** are \$5,000 + GST, to a maximum of \$3,510,000 per year + GST (15.0% of \$23,400,000 annual operating budget).
